3/2/95 initial meeting - this idea is the brain-child of Dave Chandler, Executive Director

Dave, Tom & Deanna explained their basic idea. Numerous possible activities were mentioned including: retail, art gallery, photography, 12 step programs, coffee shop, counseling, job bank, computers, referrals to existing community services. It was mentioned that both UofA and PCC have Centers for Service Learning. Molly McKasson has expressed interest. George Garcia's project he calls "The 4th R" meaning "Readiness for Life". Planned Parenthood would loan someone to hold classes and/or individual talks.

Wanting to have some activities for youth this summer, we brought up organization and the need for a building or space from which to operate. Tom mentioned operating under the umbrella of an existing non-profit and that he is part of one that probably could be used. Some attendees felt that we need form a new 501(c)3. It was pointed out that obtaining IRS status would take 18-36 months.

Discussion turned to how to find a building that could be renovated by youth over the summer. The PCC representative said that possibly with grant funds already available, youth in construction classes could be paid small wages while doing the work. The original signup sheet was passed around asking that people willing to be on a steering committee place a star next their names. Dave then asked that all of those people decide on a day, time and place for a meeting. We chose 6p 3/6 at Pima Co. Parks & Rec.

3/6/95 Steering Committee decided to pursue finding a building with Tom spearheading consider: proximity to Ronstadt Center, minimum 2 yr availability, extent of renovation that will be required, min/max footage, expandibility, cost to bring to codes ex: restrooms, etc, initial cost, monthly cost of utilities etc., can it meet codes for particular costs like retail and restaurant must be suitable for services and activities

Some members were to meet with Leslie Fisher on Thursday.

Deanna will prepare an invitation to next general meeting to be 3/23 for distribution at High Schools, the Teen Town Hall and elsewhere

3/22/95 General Meeting - downtown library.

Pima Co International Business office said they are interested in involving youth in some of its activities and would very much like some high school aged interns.

TPAC said they have great amounts of computer equipment available to youth, would love for them to use it, maybe producing stuff for sale. TPAC also would give computer graphics and related classes.

DPC's Steve Eye expained the spaces and activities that he already has available and those that he is in the process of developing.

We saw the very real possibilty of a Storefront-DPC-TPAC coalition.

ML announced that she had submitted a couple of proposals for small photography grants.

It was mentioned that some ADOT buildings were available in the downtown area for minimal annual rents but had to be brought up to code. Tom's group will look into. It was decided that the Storefront now needs a mission statement to present with grant applications, to prospective landlords, additional people that we would like get involved, and businesses that might have manpower, assets or seed money to offer. We decided on a meeting to draft a mission statement at 6p 3/27 at TPAC.

3/27/95 Mission Statement. Tom, Dave, Deanna, Jan and Heather hammered out a rough draft Dave and Tom will polish it.

4/20/95 General Meeting. Copies if the completed mission statement were passed out. An ADOT building is available for \$300 per year but estimates to bring it up to code range as high as \$100,000 and utilities could run \$2000 per month. The ground floor of the Cele Peterson building might be available, a proposal has been sent to the leasing agent.

We could participate in the Downtown Music Festival on Saturday 5/6/95. We could pass out literature about the Storefront. We also could sell something or do some other kind of fundraiser. Lillian suggested that we need something eye-catching, maybe a t-shirt to sell.

D.A.R.A. has a small grant available for entreprenurial work this summer.

Tom will be offering a class at Project M.O.R.E. that focuses on an action plan for the StoreFront Project.

Roger suggested that we have a sub-title that at least hints at what we are going to be doing; something like "Bridges to Your Future".

Heather announced that she has done lots of ground laying for a benefit concert. Some bands have agreed to perform without charge and Steve Eye of the DPC has agreed to a split of proceeds. She and Deanna were named co-chairs for the Benefit committee.

Dave said that it is time to have a small committee work on organizational structure. Tom said that we can operate under the Little Hill Foundation which is mostly inactive but has the IRS 501(c)3 exemption.

 - exhibit at M.O.R.E. have fliers saying that items can be previewed there Heather knoes the owner of the 4th Ave Gallery that will help and maybe let us display at his place
- Bob McKay has said that for-credit classes can be held by the Storefront, unusual ones even one day classes
- D.A.R.A. has a small grant for Young Entreprenurs that should be available soon Dave wants to soon get to where we can reimburse contributors for ingredients of baked goods and the be able to pay people \$5/hr for working the booth
- Heather & Kevin think that we should stay on Pennington & maybe have a skater demo and other attractions when bands art not available
- we want to do something at Sat dntn 5/20 if Ed's Club Dada will be open or, let's try for a really good night on 6/3
 - Dave suggests we get a booth and have dream catchers, shirts & fliers near Ronstadt and cookies etc on Pennignton
- Finances: we need to pay the bills for the t-shirts already made (and many sold) ~\$54 have \$10 from Kevin's sale
 - need to open bank A/C
- Event: Kevin; alot of people he knows want a big disco party he's trying to put one\
 together maybe at Ed's place or maybe Time Market warehouse
 Pennington cannot be closed until 7pm but Scott can any time, can Ed's doors
 doors be open for bathrooms? or should we try for porta -johns?
- Newsletter: Kifka will help Deanna do it regularly. Deanna dropped off a rough prototype.
- Funding: Heather says that every Thursday morning at the Library there is a grant meeting. Ann from Wingspan told her about it. The meetings include grant writing assistance and information about what is available.

 Jim Moffitt is a full-time grant writer with TUSD and a good friend of Tom's wife. Heather knows Nick of the Highland Free School. Nick is an educaator who works with kids up through Jr. High. Maybe his kids would produce art for us to sell.
- Banking: Jan will open an account with BofA. We will use the Little Hill Foundation tax ID #80-0520526. Tom, Deanna and Jan will be signers with two signers required on each check.
- Events: Heather will try to get with Deanna to do a bands event. Dave suggests we get into the lottery for booth permits for May 20th and June 3rd at Downtown Sat. nights. Vending cannot begin before 7pm at Ronstadt but maybe we can find another spot for earlier in the day. Jeff is the owner of the parking lot used last time. We need to build a good relationship with him, i.e. pick up trash.
- Organization: We need to set more structure. Kevin will start working on the computer, updating the mailing list and setting up the newsletter.
- Projects: Dave suggests additional shirt designs and maybe bumper stickers. Kevin thinks we might be able to sell tapes of local bands. Dave will try for a booth for the 5/20 Downtown Sat night, Heather will take it from there. We could print shirts on-sight at some Downtown Sat nights using a portable press.
- Money: Tara owes \$20 for dream-catchers. Collected \$20 from Dave and \$10 from ML for shirts. Heather owes \$10 for a shirt. We voted that Kevin take a shirt to his Mom for Mother's Day. Kevin is taking all remaining shirts to place on consignment for sale at various places, possible Toxic Ranch, Itchy Foot Moe's, Club Dada.
